



**Overarching Areas of Support:** 





#### **Project Summary**

Our youth are experiencing a uniquely challenging behavioral health crisis, compounded by a workforce crisis and recovery from a global pandemic, compelling us to be fiercely creative and pragmatic with the resources we can bring to bear. Using an innovative school- and primary care-based model, we will rally and prepare the broader education and healthcare workforces to better support the front lines of behavioral healthcare.

Leaders from the Departments of Psychiatry, Pediatrics and Population Health at Dartmouth Health (DH) in rural western NH have assembled a consortium of organizations with a shared mission to reduce the behavioral health challenges facing the youth in our area. The consortium includes school districts, pediatric primary care practices, NAMI-NH, and several community organizations, as well as advisory positions for state government agencies that support children's healthcare, welfare, and education. Together we will launch prevention, treatment, and recovery programs specific to the school and primary care settings in each community, wrapping in other resources to build a safety net for our youth. Highlights include:

- Broad screening for BH and social determinants of health concerns accompanied by brief intervention, referral to treatment, and care navigation support
- Increased clinician capacity to support schools and integrated into pediatric primary care
- New school-based programs including: a social-emotional skills curriculum (e.g., 'Miss Kendra') in elementary schools; group and individual behavioral health interventions in middle and high schools for at-risk students; and peer mentoring in high schools
- Piloting of digital applications to help support students working with peer mentors
- Professional staff training, consultation, and mentorship to support all programs
- Monthly interdisciplinary case-based clinical meeting to support high quality clinical care, debrief safety concerns, and discuss high risk clinical cases

#### **Project Summary**

Southern Healthcare Collaboration, Inc., and the consortium will enhance safety net features for youth and families throughout Appling and Bacon Counties, addressing needs for additional providers, additional supportive services, additional prevention and awareness, additional training opportunities, and enhanced community coordination to better protect youth. Regular mental health and SUD screenings will be offered in schools, and after school care programs will be established. Naloxone will be distributed, and trainings offered for staff and families. Bacon and Appling Counties will add a Psychiatric Mental Health Nurse Practitioner, a Healthcare Navigator, School-Based Counselor, Behavioral Health Training Specialist, two ABA Therapist/Registered Behavior Technicians, and a Transportation Coordinator. Peer parent support programs will be established for parents. Relevant providers in the region will become Certified Mental Health Technicians. Local colleges will send 30 students annually to complete Rural Health rotations at pediatric and family practice locations in Appling and Bacon Counties. Peer mentor groups will be established for paraprofessionals, youth development professionals, and community members, with training in Youth Mental Health First Aid and naloxone distribution. Transportation and daycare services will be provided to support families so parents can attend appointments with their children. After school programming will be recovery friendly to support positive youth development. Families will be connected with fresh produce. The Healthcare Navigator will work with community providers to enhance discharge coordination from emergency departments and juvenile detention centers to ensure smooth transitions to community-based care.

# **Project Summary**

Unison Behavioral Health's (UBH's) RCORP Child and Adolescent Behavioral Health (CABH) goals are to address critical prevention, treatment, and recovery needs of children and adolescents in three counties in its catchment area: Atkinson, Clinch, and Coffee Counties in rural southeast Georgia. The target rural population is children and adolescents between the ages of 5-17 living in rural Clinch, Coffee, and Atkinson Counties, which are designated 100% rural by HRSA.

Project goals include:

- Purchasing a mobile health van to provide more accessible and flexible behavioral health counseling to children and adolescents at more convenient and welcoming locations and in a comfortable, trauma-informed environment.
- Implementing an afterschool program in Coffee County in year one and one additional county prior to the end of grant funding.
- Implementing evidence-based Community Resiliency Model (CRM) training for community members in the target area.
- Developing two archivable continuing education webinars to train primary care providers, pediatricians, and other clinicians on mental health/substance use disorder screening, pharmacology, and providing support for referrals.
- Establishing at least one recovery program for children and adolescents within the target area.
- Establishing a referral process with local hospitals for children/youth admitted to the emergency department with an overdose diagnosis and developing a system to follow up with referred children and youth.
- Training for clinicians, paraprofessionals and community members will be implemented including training to reduce stigma related to SUD/OUD and behavioral health as well as training on Adverse Childhood Experiences (ACEs), Teen Mental Health First Aid (TMHFA), community resiliency model, and other evidence-based training.

# **Project Summary**

H.O.P.E will build a consortium of local partners in Pickens County, Alabama, and surrounding areas to provide services to address youth mental and behavioral health (including substance use) along the entire continuum of care, including prevention, treatment, and recovery. The goals of the program are to establish new behavioral health prevention, treatment, and recovery services for children and adolescents aged 5-17 years in Pickens County and surrounding areas. H.O.P.E. will partner with schools to increase the capacity to screen, refer, and provide mental and behavioral health treatment to children, adolescents, and families.

**Prevention.** We will implement online mental health awareness training (MHAT) for all project professionals and paraprofessionals. Interns assigned to target schools will receive training related to ACEs, trauma, and SU risk behavior in support of the screening process. In collaboration with target area public schools, we will facilitate the training and delivery of the FAST family engagement prevention program. Finally, H.O.P.E. will partner with local social services agencies and the faith community to link low-income youth and families to emergency services.

**Treatment.** Interns assigned to the target schools will conduct behavioral health screenings and will refer at-risk youth (if indicated) to one of the following treatment services provided through the project: 1) the FAST Intervention, 2) the SMART® Clinic licensed CSW, 2) MSW/MFT interns working in the schools, or 3) to the Capstone Family Therapy Clinic teletherapy services.

**Recovery.** Mentorship and support for youth and families in recovery will be provided by trained behavioral health peer support specialists who have received specialized training through an HRSA-funded program, to reduce stigma surrounding mental and behavioral disorders, and to lead support groups and other programs to promote fellowship among students in recovery.

This project will leverage community resources to establish and strengthen child and adolescent behavioral health (BH) services in Northumberland, Schuylkill, Snyder, and Union Counties, Pennsylvania, to:

- 1. Establish new behavioral health prevention, treatment, and recovery services for children and adolescents.
  - a. Implement at least one evidence-based afterschool program in the targeted communities with a specific focus on increasing emotional and social competencies and reducing behavior challenges.
  - b. Implement a community- and family-based treatment model to address increasing rates of problematic sexualized behavior.
  - c. Expand social and peer-based recovery networks to provide support to children and adolescents.
- 2. Improve the capacity of rural health care providers, paraprofessionals, non-clinical staff, and community members to care for and support children and adolescents with BH needs through training and peer mentorship.
  - a. Increase the capacity of clinicians, paraprofessionals, non-clinical staff, and community members to reduce substance use and build resilience in youth.
  - b. Implement a learning collaborative to provide opportunities for peer mentorship and to support uptake and implementation of evidence-based trainings delivered through the project.
- 3. Build community partnerships to ensure that children and adolescents, and their families, have access to community resources and human services that support prevention of, treatment of, and recovery from BH disorders.

These aims can be achieved through the partnership of: UPMC Center for High-Value Health Care, Community Care Behavioral Health Organization, Columbia, Montour, Snyder, and Union Counties Behavioral Health & Developmental Services, Schuylkill County Department of Human Services, Office of Mental Health and Development Services, Northumberland County Behavioral Health/Intellectual and Developmental Services Program, and Behavioral Health Alliance of Rural Pennsylvania.
